GUIDELINES FOR HEALTH & SAFETY / RISK ASSESSMENTS FOR SCHOOL/GROUP VISITS

- Pre-tour visits welcomed.
- Liaise with school/group leader re: requirements of the visit.

General Health & Safety Checks - on going

<u>Daily (outside)</u>

- Animal health
- Fencing
- Work areas/ use of tools
- Appropriate display of notices (whilst work in progress or during lambing, kidding or farrowing)
- Play areas

<u>Building</u>

- Provision of hand-washing facilities outside (including soap and paper towels) and inside with toilets.
- Access to baby change and disabled toilet.
- Shop/café/building access points
- Exits clearly signed

<u>Fire Procedure (should mention in meet & greet talk to teachers)</u>

• To exit building by nearest safe exit point and assemble in the car park

<u>First Aid Facilities (should mention in meet & greet talk to teachers)</u>

- First Aid kit kept in the office
- Accident book kept in the office
- Qualified First Aiders (at least one is on site at all times)
- Appointed Health & Safety contact

<u>Car Park</u>

• Ensure adult supervision when passing through the car park

<u>Guided Tours</u>

• Liaise with staff

- Carry out periodic evaluations re: services provided
- Meet & greet talk covers issues such as
- Hand washing/toilets
- Not eating, drinking, putting fingers in mouth or kissing animals during tour.
- We provide the food for the animals. Follow the directions of the tour leader. Only touch / feed those encouraged to do so.
 Not the pigs or horses. Mention at the start of the tour and again before we get to the animals and the reasons for this.
- Petting Area, seating is on bales of new straw.
- Horses seen in field.
- Horse Rides booked in advance. Provide hard hats and specialist safety equipment e.g. Devonshire boots on stirrups to stop feet slipping through. Minimum of three staff, 1 to lead, 1 to side walk and 1 to help with mounting and dismounting.
- Classroom for approx. 30 children
- Follow tour leader around the farm
- If staying for dinner, encourage groups to leave packed lunches on coaches or in the classroom provided.
- Only book in one large group at a time

<u>Hand washing</u>

Hands must be washed thoroughly with soap and water

- after touching the animals, fences or other surfaces in animal areas
- after removing dirty shoes or boots that have been worn on the farm
- before eating

Gels and wipes do not remove all the bacteria [including e.coli] that is in dirt.

Picnic Areas

• Away from the animals

<u>Glasshouse</u>

• Out of bounds. Access points are kept locked

<u>Tools</u>

• Kept locked away when not in use. Site tidied at the end of the day.
